As part of our topic of 'Home Sweet Home', Reception braved the icy temperatures this morning to build a home for a hibernating creature. We learnt about which creatures hibernate, why they need to do it and how. We also learnt about the different hibernating sites they make, then armed with a collection of cuddly creatures, we set out to create spaces that were warm, safe and quiet.'

In Year 1, the children were unpicking a crime scene left by the Evil Pea—they were horrified to find what he had done in their classroom—which went against all our school values!. In Year 2, I was impressed by their group reading sessions which I mentioned was going to be implemented in Reception, Year 1 and 2. Miss Kavanagh, our Phonics Lead and Miss Chatfield will be writing to you to explain how to log in to their new reading books. The children read three times a week in school. The first read will be for fluency, the second is for 'prosody', which is to do with patterns and fluency, and the third for comprehension. The children will be looking forward to sharing with you their Celebratory Read with parents at home. Please look out for your child's log in details which will be coming out to you!

Year 3 have been thoroughly engrossed in their science topic, rocks and soils. This week they have looked at fossils inside rocks and learnt to draw them. Year 4 have also been enjoying science, investigating vibrations which can be seen using a tuning fork in water. At the time of writing I have left year 5 in mid competition between the teachers and their classes on who knows their talk for writing shared text the best!

This week, we have continued our weather topic by focusing on wind and its effects and use.

We have made boats in different forms, even sailing them to see if we can alter their direction by the power of wind.

We have enjoyed several experiments, testing objects to see which are light enough to be moved by wind. We have also explored the power of a large fan with paper streamer and balloons. We have also worked on our fine motor skills by using pegs to fix washing on a line as well as enjoying Shaving foam play mark making clouds.

The children have loved pretending to fly in our own nursery hot air balloon, using binoculars to see what they could spot on their travels.



Please can we ask adults to supervise any children at the start and end of the day—children should not be climbing any of the outdoor play equipment. Thank you for your co-operation.

## ADHD MEDICATION

The government has announced a national shortage of medicines used to help manage ADHD symptoms. The shortage of these products is being caused by a combination of manufacturing issues and increased global demand; it is expected that the delay will impact until at least December. This is going to be a difficult time for fami-

lies, and the Surrey and Borders Partnership NHS Foundation Trust want to help schools feel equipped with the necessary resources to be able to prepare and support these families over the next few weeks.

We will be contacting all affected families over the next week to update them on the national issue and set out our advice. This will include children and young people currently on, and those awaiting an initial appointment to discuss and potentially commence, medication following an ADHD diagnosis. At present we are asking parent-carers to take a look at our information and resource page for <u>Neurodevelopmental needs</u> on the Mindworks website. This page, which has recently been updated, provides signposts to lots of helpful strategies and interventions to support ADHD symptomology as well as some medication advice under the <u>ADHD section</u>. Parent-carers should also keep up to date with our <u>talking point</u> section of the Mindworks website which will be updated regularly.

We'd particularly like to draw attention to this statement: <u>National ADHD Medication shortage: Mindworks Surrey</u> (<u>mindworks-surrey.org</u>) which includes an important reference to what families should do where a child/young person is taking guanfacine (Intuniv<sup>®</sup>). This medication should not be stopped suddenly as it can cause the child/young person to experience high blood pressure, so parents / carers are being asked to only contact us if they are having difficulty obtaining guanfacine on 01372 216555, lines are open 9am to 12:30am.



#### ACTION: UKHSA advice for education and childcare settings amid high levels of flu, COVID-19 and scarlet fever

As winter illnesses continue to circulate at high levels and pupils are returning to education, the UK Health Security Agency (UKHSA) has published a <u>reminder on how to minimise the spread of illness in education and childcare settings</u>. UKHSA advice remains clear that children can continue to attend as normal unless they are unwell and have a high temperature. <u>Further information</u> on when a child is too ill for school or nursery is available. There is no requirement to be absent from school on a precautionary basis. School staff should continue to maintain their high expectations for face-to-face attendance. For further information, please also see our Education Hub post on the <u>latest guidelines around COVID-19</u> and for Strep A, our separate post on the <u>exact circumstances in which children should be kept off school</u>.UKHSA is providing regular updates on <u>Strep A</u>. Both UKHSA and DfE are continuing to closely monitor the situation. To help reduce the risk of some illnesses, including flu, vaccinations are being provided in schools. UKHSA, in collaboration with NHS England and DfE, have produced a <u>briefing for secondary schools</u> giving details about all vaccines offered to adolescents in schools and the role that schools play. This includes information on the flu vaccination programme being offered this year to those in Years 7, 8 and 9.

If any children are on antibiotics 4 times a day—this can be administered in school—please come to the office to complete a form and speak with the office staff regarding administration of this.





#### FOR NEWSLETTER FOR ALL PARENTS FROM SCHOOLS

#### Dear Parent/Carer

We are aware that the pandemic has had an effect on families, but the expectation is still that every child should now be attending school full time. If you consider that there are exceptional circumstances relating to your request, please let the school have full details. Each application for a leave of absence will be considered on a case by case basis.

#### Penalty Notices to Address Poor Attendance at School

A Penalty Notice may be issued as an alternative to the prosecution of a parent/carer for their child's unauthorised absence from school (absence without the agreement of the school or not covered by a medical note) and will be used by Surrey County Council in the following circumstances :-

- 1. Pupils identified by police and Inclusion Officers (formerly Education Welfare Officers) engaged on Truancy Patrols and who have incurred unauthorised absences.
- 2. Leave of absence in term time (5 days or 10 sessions or more).
- Please be aware that The Education (Pupil Registration)(England)(Amendment) Regulations 2013, which became law on 1st September 2013 state that Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances.
- The Headteacher is also required to determine the number of school days a child can be away from school if leave is granted.
- In such cases the Headteacher/Governing Body must decide whether there are exceptional circumstances. They may request that the Local Authority issue Penalty Notices when the absence is not authorised. Warnings will not be given where it can be shown that parents have been notified that such absences will not be authorised.
- 3. Finally, the issuing of a Penalty Notice will also be considered where it is judged that a parent is failing to ensure their child's regular school attendance. This will be considered when a pupil has incurred 7 or more unauthorised sessions in the previous 6 school weeks, which may include a pupil arriving late after close of registration. If you believe at any stage that your child's absence from school may leave you liable to receive a Penalty Notice, it is extremely important that you act without delay to secure their regular attendance. If you have any questions or require further support to achieve an improvement in your child's attendance, please contact your child's school or the Inclusion Officer.

#### **Penalty Notice relating to Exclusions**

If a child is excluded from school, Section 103 of the Education and Inspections Act 2006 places a duty on parents/carers to ensure that their child is not in a public place without justifiable cause during school hours. This duty applies to the first five days of each exclusion. Failure to do so will render the parent/carer liable to a Penalty Notice. (Alternative education provision will be made available from the sixth day of any exclusion.)

#### Amount Payable for a Penalty Notice

The amount payable for a Penalty Notice issued in any of the above circumstances is currently £60 if paid within 21 days of receipt of the Notice, rising to £120 if paid after 21 days but within 28 days. If the Penalty Notice is not paid, the local Authority must consider a prosecution in the Magistrates Court for the offence for which the Notice was originally issued. Please be aware that each parent is liable to receive a Penalty Notice for each child who incurs unauthorised absences, for example, if there are two parents and one child, each parent will receive one Penalty Notice. If there are two parents, and two children incur unauthorised absences, each parent will receive two Penalty Notices, which in this case would amount to £120 each if paid within 21 days.
