If your child has been sick or has an upset stomach, children may be off school for 48 hours following the last episode, each case is dealt with separately. # ADHD MEDICATION

The government has announced a national shortage of medicines used to help manage ADHD symptoms. The shortage of these products is being caused by a combination of manufacturing issues and increased global demand; it is expected that the delay will impact until at least December. This is going to be a difficult time for fami-

lies, and the Surrey and Borders Partnership NHS Foundation Trust want to help schools feel equipped with the necessary resources to be able to prepare and support these families over the next few weeks.

We will be contacting all affected families over the next week to update them on the national issue and set out our advice. This will include children and young people currently on, and those awaiting an initial appointment to discuss and potentially commence, medication following an ADHD diagnosis. At present we are asking parent-carers to take a look at our information and resource page for <u>Neurodevelopmental needs</u> on the Mindworks website. This page, which has recently been updated, provides signposts to lots of helpful strategies and interventions to support ADHD symptomology as well as some medication advice under the <u>ADHD section</u>. Parent-carers should also keep up to date with our <u>talking point</u> section of the Mindworks website which will be updated regularly.

We'd particularly like to draw attention to this statement: <u>National ADHD Medication shortage: Mindworks Surrey</u> (<u>mindworks-surrey.org</u>) which includes an important reference to what families should do where a child/young person is taking guanfacine (Intuniv<sup>®</sup>). This medication should not be stopped suddenly as it can cause the child/young person to experience high blood pressure, so parents / carers are being asked to only contact us if they are having difficulty obtaining guanfacine on 01372 216555, lines are open 9am to 12:30am.



#### ACTION: UKHSA advice for education and childcare settings amid high levels of flu, COVID-19 and scarlet fever

As winter illnesses continue to circulate at high levels and pupils are returning to education, the UK Health Security Agency (UKHSA) has published a <u>reminder on how to minimise the spread of illness in education and childcare settings</u>. UKHSA advice remains clear that children can continue to attend as normal unless they are unwell and have a high temperature. <u>Further information</u> on when a child is too ill for school or nursery is available. There is no requirement to be absent from school on a precautionary basis. School staff should continue to maintain their high expectations for face-to-face attendance. For further information, please also see our Education Hub post on the <u>latest guidelines around COVID-19</u> and for Strep A, our separate post on the <u>exact circumstances in which children should be kept off school</u>.UKHSA is providing regular updates on <u>Strep A</u>. Both UKHSA and DfE are continuing to closely monitor the situation. To help reduce the risk of some illnesses, including flu, vaccinations are being provided in schools. UKHSA, in collaboration with NHS England and DfE, have produced a <u>briefing for secondary schools</u> giving details about all vaccines offered to adolescents in schools and the role that schools play. This includes information on the flu vaccination programme being offered this year to those in Years 7, 8 and 9.

If any children are on antibiotics 4 times a day—this can be administered in school—please come to the office to complete a form and speak with the office staff regarding administration of this.

# Updated guidance—Winter 2023

UKHSA have provided a number of guidance documents and resources to support schools and other childcare settings in managing outbreaks of common infections which can spread easily amongst children (and potentially staff). Infections such as norovirus, scarlet fever and respiratory illnesses (including flu) are more common in the winter months.

Outbreaks can be disruptive to children's education and to the running of the setting. It is important that staff know what actions to take to help reduce the risk of onward transmission if cases of infectious illness are identified, and how to seek further advice and support.

UKHSA have updated the outbreak management documents for Surrey specific educational settings for winter 2023. They include the contact details for the local UKHSA Health Protection Team (HPT) and for your local contacts in Surrey. They also set out the information that the HPT will need to have from you should you need to contact them for advice. **These** documents can be found on the Area Schools Support resources page on the <u>Surrey Education Services</u> website.

# Preparing for a measles resurgence in England

#### Autumn 2023 update.

You were contacted earlier in the year about measles by the UK Health Security Agency (UKHSA), and a further request has now been received, to remind schools and childcare settings about the ongoing need to increase uptake of both doses of the measles, mumps and rubella (MMR) vaccine.

UKHSA recently published a measles risk assessment which concluded that although the risk of a UK-wide measles epidemic is considered low, a measles outbreak of between 40,000 and 160,000 cases could occur in London, due to sub-optimal up-take of the measles, mumps and rubella (MMR) vaccine in the capital. Outside of London there is a high risk of cases linked to overseas travel leading to outbreaks in specific groups. There has been a <u>steady rise in measles cases this year</u>.

Education and childcare settings play a key role to play in promoting uptake of vaccinations because of the relationship you have with parents and young people.

We would be grateful if settings could assist with the following actions:

Leaflets for parents can be downloaded for printing out or for emailing. #### Prize for every child reaching their goal

Surrey Libraries are encouraging every child and their responsible adult to visit their local Surrey library to pick up their books and start reading! Besides picking up books from their Surrey library, children can borrow books from their school library, and download for free Surrey Libraries' eBooks, eAudiobooks and eComics. All reading counts! Once a child has reached their online goal, they can collect a prize in one of our libraries\*. They can bring along their printed certificate or show the e-certificate to a staff member or volunteer on a device like a mobile phone, and they can collect a prize (suitable for 3+ year olds, available in most of our libraries, and as long as stock lasts). Please note that a child must be a library member to collect their prize. If someone isn't a member yet, they can join the library <u>online</u> or at their <u>local library</u>. Library membership is free.

#### What can schools do to support the Winter Mini Challenge?





#### FOR NEWSLETTER FOR ALL PARENTS FROM SCHOOLS

#### Dear Parent/Carer

We are aware that the pandemic has had an effect on families, but the expectation is still that every child should now be attending school full time. If you consider that there are exceptional circumstances relating to your request, please let the school have full details. Each application for a leave of absence will be considered on a case by case basis.

#### Penalty Notices to Address Poor Attendance at School

A Penalty Notice may be issued as an alternative to the prosecution of a parent/carer for their child's unauthorised absence from school (absence without the agreement of the school or not covered by a medical note) and will be used by Surrey County Council in the following circumstances :-

- 1. Pupils identified by police and Inclusion Officers (formerly Education Welfare Officers) engaged on Truancy Patrols and who have incurred unauthorised absences.
- 2. Leave of absence in term time (5 days or 10 sessions or more).
- Please be aware that The Education (Pupil Registration)(England)(Amendment) Regulations 2013, which became law on 1st September 2013 state that Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances.
- The Headteacher is also required to determine the number of school days a child can be away from school if leave is granted.
- In such cases the Headteacher/Governing Body must decide whether there are exceptional circumstances. They may request that the Local Authority issue Penalty Notices when the absence is not authorised. Warnings will not be given where it can be shown that parents have been notified that such absences will not be authorised.
- 3. Finally, the issuing of a Penalty Notice will also be considered where it is judged that a parent is failing to ensure their child's regular school attendance. This will be considered when a pupil has incurred 7 or more unauthorised sessions in the previous 6 school weeks, which may include a pupil arriving late after close of registration. If you believe at any stage that your child's absence from school may leave you liable to receive a Penalty Notice, it is extremely important that you act without delay to secure their regular attendance. If you have any questions or require further support to achieve an improvement in your child's attendance, please contact your child's school or the Inclusion Officer.

#### **Penalty Notice relating to Exclusions**

If a child is excluded from school, Section 103 of the Education and Inspections Act 2006 places a duty on parents/carers to ensure that their child is not in a public place without justifiable cause during school hours. This duty applies to the first five days of each exclusion. Failure to do so will render the parent/carer liable to a Penalty Notice. (Alternative education provision will be made available from the sixth day of any exclusion.)

#### Amount Payable for a Penalty Notice

The amount payable for a Penalty Notice issued in any of the above circumstances is currently £60 if paid within 21 days of receipt of the Notice, rising to £120 if paid after 21 days but within 28 days. If the Penalty Notice is not paid, the local Authority must consider a prosecution in the Magistrates Court for the offence for which the Notice was originally issued. Please be aware that each parent is liable to receive a Penalty Notice for each child who incurs unauthorised absences, for example, if there are two parents and one child, each parent will receive one Penalty Notice. If there are two parents, and two children incur unauthorised absences, each parent will receive two Penalty Notices, which in this case would amount to £120 each if paid within 21 days.
